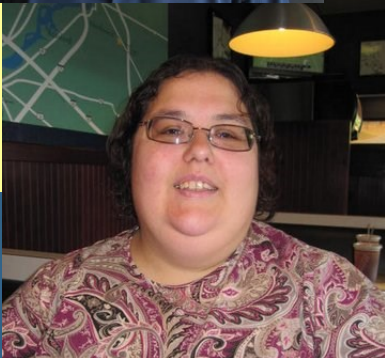

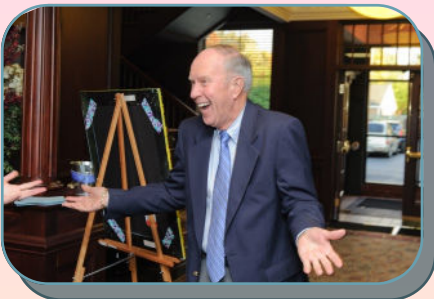

Thank You for Being a Friend of Toledo/Lucas County CareNet . . .

CareNet was created in 2002 to fill the cracks in the health care system so that low-income, uninsured residents of Lucas County would have access to the healthcare they need. With the Affordable Care Act, those cracks are changing and CareNet is changing too.

CareNet advocated for Medicaid expansion for those who earn up to 138% of the Federal Poverty Level--the working poor--individuals with annual incomes of up to \$16,000/year. After much effort, Medicaid Expansion was approved in Ohio beginning January 1, 2014.

As a result, CareNet serves in the role of Navigator—assisting all eligible Northwest Ohio residents enroll in Medicaid and the Health Insurance Marketplace, while at the same time continuing the CareNet program for the thousands of Lucas County Residents who fall through the cracks because their income is too high for Medicaid but not high enough to afford Marketplace coverage, or because they are not US Citizens.

Due to the historic impact of Medicaid Expansion, which as of September has resulted in 80% of eligible Lucas County residents enrolling, the CareNet Board has seized this opportunity to focus on making Medicaid work for the individuals who depend on it while focusing on creating a return on investment for the community as a whole.

Medicaid coverage is a huge improvement from being uninsured. However, like most things, Medicaid isn't perfect. The system to enroll and access care through Medicaid is complex. There are not enough providers, the reimbursement rate is low, and the wait time can be long. Navigating the healthcare system as a new Medicaid recipient is like driving through Toledo during orange barrel season. We are traveling on the healthcare access road while we are building it.

To achieve CareNet's mission, "To increase access to coordinated healthcare services for low income residents of Lucas County," CareNet is focused on:

- Increasing enrollment into coverage.
- Providing a charity care network for the uninsured.
- Translating insurance cards into access to care and quality of life through care coordination.

With your continued support, CareNet will continue to be a healthcare advocate for the working poor in Lucas County.

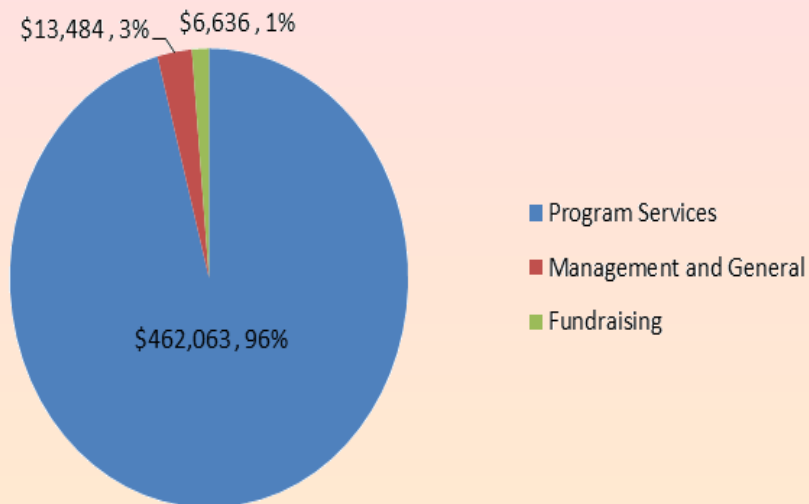

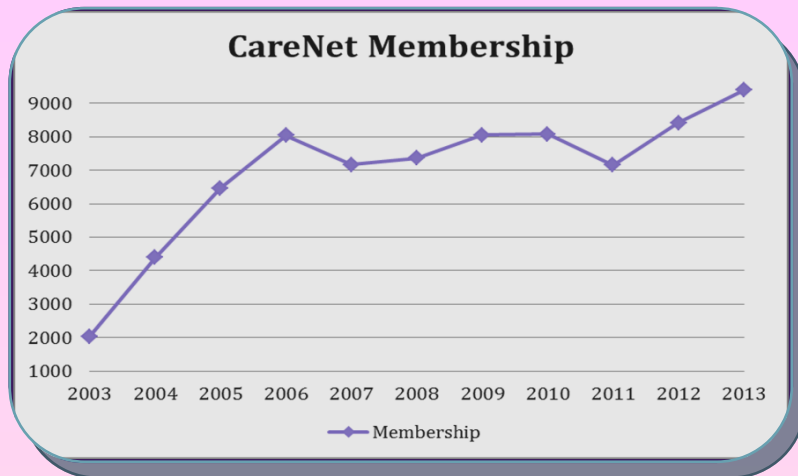

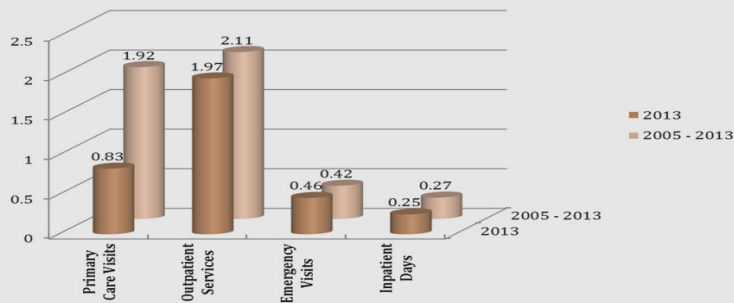
Decrease in the Number of Uninsured

Served an all-time high of 9,390 CareNet members in 2013

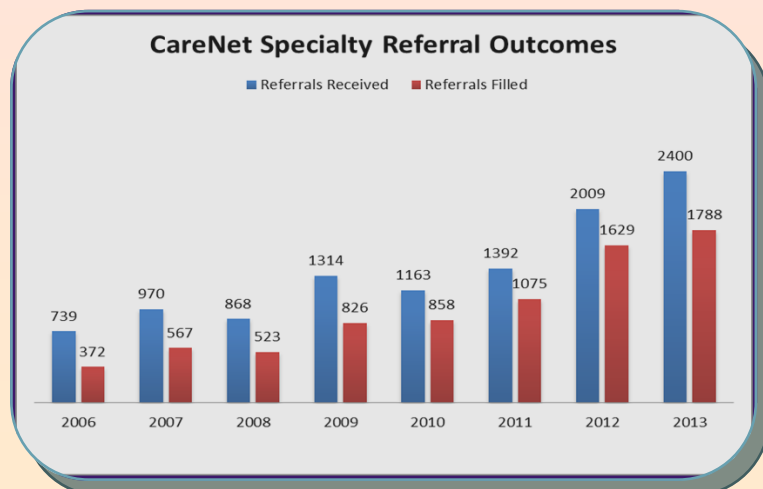


Preventive Care

Before moving to the United States, Louay Salman had a life in Syria as an engineer, but that life was filled with fear and struggling to survive.

In 2013, Louay decided to move with his two sons to the United States to escape threats and uncertain life circumstances. That year, he and his sons arrived in Toledo to begin a new life.

Once he arrived in Toledo, Louay enrolled in ESL classes through the Sylvania Schools Administration which allowed him to meet outstanding

teachers. One of those teachers was Marge Sander, who informed Louay of CareNet. Through CareNet, he was able to receive a flu shot and also got help with back pain and ear infections.

CareNet became a saving grace for Louay. Before CareNet, he felt he had “nowhere to go” for healthcare, but now he feels “safer” knowing he has access to dependable care.

Louay is grateful that he now has a safe place for his family to call home. He is also espe-

cially grateful to Dr. Suresh Ramnath, and Nurse Practitioners Vaughan Hoblet and Suzanne Corado for being kind and providing excellent care. He also thanks his ESL teacher, Marge Sander, CareNet, and Lucas County.
