Since starting as a charity care network in 2002, Toledo/Lucas County CareNet has helped tens of thousands of low-income Lucas County residents get the care they need. That includes providing care coordination to low-income residents like Jessica Powell, who received help from CareNet Community Health Worker (CHW) Glori Puskarich. CHWs help clients get connected to medical coverage, a medical home, food, medications, housing, transportation and other needs.

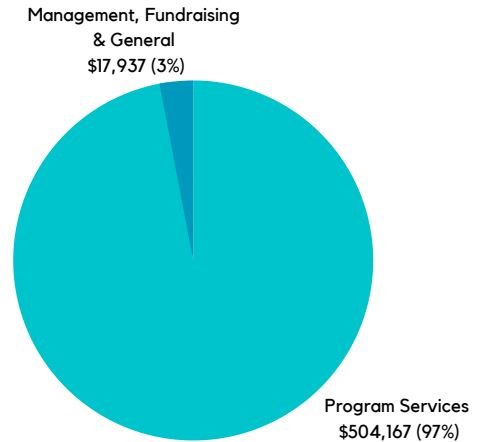
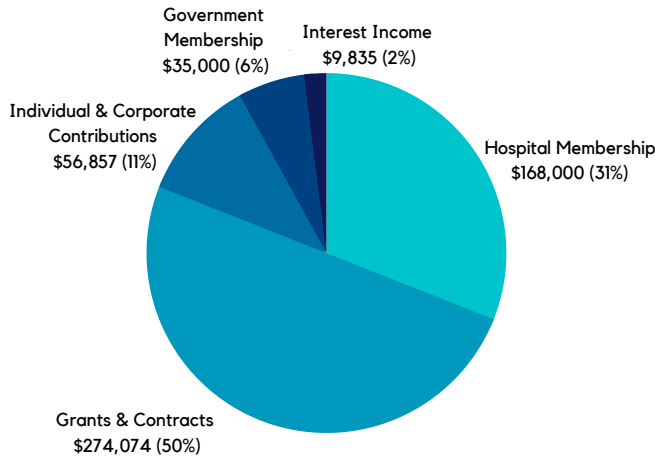
