# FROM CARENET'S EXECUTIVE DIRECTOR

Dear Friends of CareNet,

Another year is coming to an end, and Toledo/Lucas County CareNet appreciates the support the community continues to show our neighbors who need healthcare. CareNet's dedicated donors, volunteers, friends and other partners are essential to our collaborative efforts to provide access to coordinated healthcare services for low-income Lucas County residents. This annual report highlights two of many clients who are grateful for CareNet's help this year.

Since CareNet's inception 15 years ago, the organization has evolved into a strong coalition of people and organizations committed to helping people in our community get the care they need regardless of policies or payment. More than 28,000 low-income, uninsured residents of Lucas County have benefitted from CareNet's charity care network, receiving more than 500,000 healthcare services valued at more than \$200 million. That's just part of what we do.

CareNet's scope evolved starting with the passing of the Affordable Care Act, which gave residents newfound coverage options that they needed help navigating. The working poor especially need guidance using their medical coverage and meeting basic needs, such as medication, food and housing, so CareNet hired community health workers to help.

CareNet provided insurance navigation services to residents in the region until September, when Ohio lost its navigator program after a severe federal funding cut. While CareNet had to end its program, the CareNet Board has allocated resources so we can respond to requests from Lucas County residents who need help navigating healthcare coverage.

Thank you for supporting CareNet's efforts. Your assistance is needed more now than ever.

# CARENET BY THE NUMBERS



Toledo/Lucas County CareNet truly is a collaboration. Here is a look at what makes CareNet unique - and, with your support, an asset to our neighbors who need health care.



### 28.292 CARENET MEMBERS

Since 2003, CareNet has provided coordinated healthcare services to more than 28,000 low-income residents of Lucas County.



### 220 PHYSICIAN VOLUNTEERS

CareNet depends on about 220 volunteer primary care physicians and specialists to provide care to our members.



### 23 HOSPITALS & CLINIC SITES

CareNet's award-winning charity care network includes 8 hospitals and 15 clinic sites where members receive care.



### 1,674 BREAST HEALTH SERVICES

With Susan G. Komen Northwest Ohio grant funding, CareNet has provided mammograms and other services to 1,674 residents.



### 384 CARE COORDINATION

CareNet's community health workers have connected 384 residents to needed medical and social services, including medications and food.





# Lois' Story: Facing Breast Cancer on a Fixed Income

Lois Reed felt fear after learning she had breast cancer. Then the Toledo woman's thoughts turned to a different kind of fear: How to pay for added medical bills on her fixed income.

A former Toledo/Lucas County CareNet client gave Lois the phone number for Andrea Vasquez, a CareNet community health worker. Andrea started working on a comprehensive care coordination plan with Lois, who had a double mastectomy in July, not long after being diagnosed.

Using Susan G. Komen Northwest Ohio funding, Andrea helped Lois pay some bills and connected her to needed community resources. For example, Komen funding helped buy a lift chair for Lois to use after surgery, which cost hundreds of dollars even at a discounted rate.

Now that Lois is recovered from surgery and on hormone therapy, she is an advocate for breast cancer awareness and the resources available to low-income residents. A grateful Lois walked in her first Komen Toledo Race for the Cure as a survivor with Andrea in September.

# Kathey's Story: Help To Get Her Life Back On Track

Last year, Kathey Scribner lost both her small Bryan home and job after working 14½ years at a corrections facility, where her position as a case manager was eliminated. Kathey eventually found an affordable home in Toledo and a job she loves working with autistic clients in Whitehouse, but she stopped taking anti-depressants and other prescriptions to save money.

Without health insurance, much less a doctor or even adequate food, Kathey couldn't cope anymore. Visits with her adoptive daughters were often marked with sadness and tears. Kathey knew she needed help with her depression and basic needs.

Luckily, Kathey remembered her new employer had a life coach, who put her in touch with Heidi Trombley, a Toledo/Lucas County CareNet community health worker. The two met right away, and Heidi got Kathey into the Crisis Center and back on the medications she so desperately needed after going several months without them.

Heidi also lined Kathey up with the Zepf Center for ongoing therapy and attended her first appointment to help allay her fears. With Heidi's help, Kathey and her daughters now have health coverage. Kathey also has food assistance and has received help meeting other needs.


### **Return On Investment 2016**
